Making A Purchase Making a purchase could not be easier. Just browse our store, and add any items that you wish to buy into the shopping cart. After you have finished your selection, click on 'Checkout' and you will be asked for a few details that we need to be able to complete the order.

Shipping And Handling Shipping is via Royal Mail or Courier depending which service you choose.

Items will normally be dispatched within 2 working days of receiving an order and a payment.

Delivery Schedule We will dispatch your order right away. We will normally dispatch your order to you in <2> business day. International orders are generally received in under <10> working days.

You must inform us within three working days of the expected delivery date if the goods are lost or damaged in transit so that we can make a prompt claim against the delivery company

and correct the problem. Please quote your order number in all correspondence.

You agree that proof of delivery supplied by our delivery company is sufficient evidence to establish that goods have been received.
